Sub: RECRUITMENT OF ASSTT.SUB INSPECTOR (EXE)THROUGH LDCE-2018.

It is proposed to invite applications from eligible departmental candidates for filling up of 519 vacancies (UR-404, SC-77 and ST-38) of Asstt. Sub Inspector (Executive) in CISF through Limited Departmental Competitive Examination (LDCE) against the recruitment year 2018. However, vacancies may increase/decrease at the time of final selection.

- Only Constable/GD, Head Constable/GD and Constable/Tradesmen who have completed 5 years regular service including the period of basic training in the grade or five years combined regular service as Constable/GD and Head Constable/GD and Constable/Tradesmen, as on 01.08.2018 (i.e., those who have been appointed in the Force on or before 30.07.2013) are eligible to participate in this Limited Departmental Competitive Examination and they may submit their applications as prescribed vide Appendix "A" to this letter along with a certificate to the effect that no criminal/DE/ vigilance cases is pending against them as per Appendix- B-1, B-2 and B-3 through proper channel to their respective Zonal DIsG {(i.e., DIG(NZ-I) New Delhi, DIG(SZ) Chennai. DIG(WZ-I) Mumbai, DIG(EZ) Patna and DIG(SEZ) Kolkata) provided they fulfill the eligibility criteria as mentioned in Para-6 below. Other appendices such as Appendix-C and Appendix-D are also to be completed in cases wherever applicable.
- It is again reiterated that applications are to be submitted to Zonal DIsG viz., DIG(NZ-I) New Delhi, DIG(SZ) Chennai, DIG(WZ-I) Mumbai, DIG(EZ) Patna,) and DIG (SEZ) Kolkata.
- Applications of eligible candidates who are posted in the units under the administrative control of DISG Plant or DISG DAE or DOS or Airports or BNs or GBS or SSG or HQRs or in Training Institutions will be forwarded directly to the respective Zonal **DISG** mentioned in Para-3 above by the respective Unit Commanders instead of routing the same through their DIsG. For example, applications in respect of personnel posted in RAPS Kota or VSSC Thumba will be forwarded directly by the respective Unit Commanders to DIG, NZ-I and DIG, SZ respectively instead of routing the same through DIG/DAE or DIG/DOS. The respective Branch will forward applications of personnel attached with this Directorate, to their respective units from where the same will be forwarded to DIG, NZ-I, New Delhi after verifying the service particulars of the candidate. No application will be sent to Recruitment Branch. Unit Commander should ensure that the personnel on Election duty, temp duty, attachment duty etc should be informed well in time. Forwarding of applications submitted by the individuals is the duty of concerned Unit Commanders.

- 5. Applications duly completed, in respect of CISF personnel who are on deputation to outside organizations will be submitted through proper channel to the nearest Zonal DISG under intimation to their parent unit. For example, a person is on deputation to SPG New Delhi from CISF Unit, DSP Durgapur, he will submit his application to SPG who in turn will forward the same directly to DIG, NZ-I, New Delhi under intimation to DIG DSP Durgapur.

(vi) Final Selection

Name of candidates will be placed in the merit list subject to the provision that candidate belonging to General category have secured minimum 50% aggregate marks i.e., 100 marks out of a total of 200 marks and candidate belonging to SC/ST category have secured minimum 45% aggregate marks i.e., 90 marks. Final selection of candidates will be made according to availability of vacancies and subject to their being declared 'FIT' in the Detailed Medical Examination.

8. LAST DATE OF RECEIPT OF APPLICATION

All eligible departmental candidates may submit their applications duly filled in Appendix-A, B-1, B-2 & B-3 to their respective Unit Commanders by 15.12.2018 i.e., last date for receipt of applications from all eligible candidates by the Unit Commanders shall be 15.12.2018. Candidates must ensure that applicant's portion of Appendix-Á including Col.No.1 to 13, Appendix B-1, B-2 & B-3 are filled in before appending his/her signature. Last date of receipt of the above applications by the respective DIsG (Application Receiving Centre) as mentioned in Para 2 above shall be 22.12.2018. - d) Degree certificate in support of educational qualification.

Note: If there is any change/amendment in the eligibility condition, the same will be published in CISF website. Candidates may check the same from the website or from the office of Sector IsG/Zonal DIsG. Mere submission of the application does not give the candidate right to be considered unless he meets the eligibility requirements prescribed at the time of issue of admit cards.

Applications received after 15.12.2018 (the last date of receipt of application) will not be accepted and summarily be rejected.

10. RESPONSIBILTY OF THE UNIT COMMANDERS

Unit Commanders will personally ensure that:-

- a) A copy of this notification is circulated to all Coy Commanders and is also affixed on the notice board and contents of the notification are also brought to the notice of all eligible personnel.
- b) Unit Commander should ensure that the personnel on Election duty, Temp duty, attachment etc should be informed will in time. Forwarding of applications submitted by the individuals is the responsibility of concerned unit Commanders.

There should not be any column left without verification, which may lead to complications at a later stage.

- f) It should be ensured that applications are accompanied with Photostat copies of required certificates, duly attested.
- g) It should be ensured that all columns meant for the candidates—vide Appendix-A, B-1, B-2 & B-3 are filled by the candidates and the columns meant for Unit Commander is filled /completed before the same is forwarded to the DisG.
- h) Eligible personnel of the unit may be informed that <u>only three chances</u> are available for appearing in this LDCE.
